01. QUALIFICATION;

Passed Matriculation (Matriculate or 10th Class in 10+2 examination system) with minimum 50% marks in aggregate except additional marks andhaving ITI Certificate compulsory in the relevant trade from an institute affiliated to NCVT. Copies of all certificates viz. proof of date of birth, educational/technical Qualification Certificate (ITI), NCVT Certificate, Caste Certificate. Ex-serviceman certificate, OBC certificate/ Creamy Layer certificate from appropriate authority etc. duly attested by a Gazetted Officer of Central or State Govt. and must bear office seal and name of attesting officer should be submitted along with the application. No extra weight age will be granted to candidates having higher educational qualification. Candidates without ITI (without NCVT), need not apply.

02. AGE: The age will be reckoned as on 01.07.2017.

Candidate should have completed 15 years of age and should not have completed 24 years of age.

(i) Age limit of UR (General)Candidates i.e the date of birth should be within 01.07.93 to 30.06. 2002.

(ii) Upper age limit is relaxable by 5 years in case of SC/ST Candidatesi.e the date birth should be within 01.07.88 to 30.06. 2002.

Physically handicapped Certificate issued by Govt. Hospital/Medical Board as per para 4 & 5 of the Gazette Extra ordinary Published by the concerned authority dated 17.07.1999 is to be enclosed with the application.

If no suitable OBC candidate is available, trades will be filled-up by un-Reserved candidates.

05.MODE OF SELECTION

- A.
