Applications are invited from eligible citizens of India for appointment of sportspersons through open advertisement against the following sports discipline:-

There is no reservation for SC/ST & OBC being a sub-quota. However, the candidates claiming to belong to SC/ST/OBC communities are required to submit photocopy of Caste Certificate as per **Annexure-C & D**.

**2. Educational Qualification:** For appointment in Grade Pay Rs. 1900/2000 (Level- 2 OR Level- 3 of Pay Matrix as per 7th Pay Commission): 10th pass for the post of Technician- III. However, the training period for such Sports quota appointees will be 3 years, unless they possess ITI qualification in the relevant Trade, in which case it will be 6 months OR 12th (+ 2 stage) or its equivalent examination for the posts of Non-Technical Popular Categories (NTPC).

**3. Age:** (a) Minimum 16 years and maximum 25 years as on **01.01.2020 (between 02.01.1995 to 01.01.2002)**. No age relaxation (upper or lower) shall be permissible for recruitment through Open Advertisement. (b) Proof of Age viz., Matriculation certificate issued by a recognised board or equivalent must be submitted as a proof of date of birth.

**4. Sports Norms:** The minimum sports norms for recruitment of sportspersons against sports quota in different Grade Pay and Pay Bands for both team and individual events shall be as per the table shown below:

**(a) In Athletics,** medal winning performance in National Inter State Senior Athletics Championships, may also be considered for recruitment against the posts having Grade Pay Rs. 1900 in Pay Band Rs. 5200-20,200.

**(b) In Badminton,** sportspersons may also be considered for recruitment on the basis of their current Annual All India Rankings; in different Grade Pay and Pay Bands, as per following criteria:

**(d) In Cricket (Women)** at international level, representation of Main Indian Seniors Team in a Test Match or in a Limited Overs One Day International Match or in a Twenty-20 Overs Match; shall also be considered for recruitment against the posts having Grade Pay Rs. 1900 or Rs. 2000 in Pay Band Rs. 5,200-20,200 (Level- 2 & Level- 3). **In Cricket (Women)** at the National level, following sports achievements in 4 Days/One

**(e) Powerlifting:** The sports achievements in the event conducted by Indian Powerlifting Federation (IPF) or its affiliated units after 03.10.2017 shall not be considered for recruitment. However, the certificates issued by the Association of Indian Universities and the International Federations for recognized sports achievement in the game of Powerlifting will be permissible for said purpose as per RBE No. 76/2018.

**(f) Volleyball:** The sports achievements in the events conducted by Volleyball Federation of India after 20.07.2017 shall be considered for recruitment as per RBE No. 127/2017.

\* All the championships should be conducted under the aegis of recognized International/National/State sports and Federations and also recognized by the Railway Sports Promotion Board.

\* A sportsperson will be considered for recruitment only for event/position/game advertised in which he/she has recognized sports norms. Sportsperson having sports achievement/eligibility norms for post carrying higher Grade Pay will also be eligible for post carrying lower Grade Pay. **Separate applications for each category should be made along with requisite examination fees.**

**5. Period for Reckoning Sports Achievement:** Candidates must be active sports persons and their achievements during the **immediate previous 2 (two) financial years i.e., on or after 01.04.2017** shall be considered for appointment. For this purpose, concluding day of the championships/event will be taken into account. Performance in earlier championships, i.e. **prior to 01.04.2017 will not be taken into consideration.**

**6. Selection Procedure:** Short-listed eligible candidates will be called for -  
(i) Trial of sports performance.

(ii) Assessment of sports achievement & educational qualification etc.  
**NOTE: Only those candidates who perform better than the existing railway sportspersons in their respective events, and if they fit into the NFRSA team, will be considered for appointment.**

**7. Procedure for Recruitment:**

(a) Trials of the candidates shall be conducted to assess their sports performance and suitability for Railway/Unit team as well as Indian Railways team. Trial Committee shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage, by giving marks (maximum 40 marks), as per the criteria given below:

- (i) For game skill, physical fitness & coach's observations during trials : 40 Marks
  - (ii) FIT Candidate : Candidate securing 25 marks or more
  - (iii) NOT FIT Candidate : Candidate securing marks below 25
- (b) After Trial only the FIT candidates shall be considered for the next stage i.e. assessment of sports achievement & educational qualification by the Recruitment Committee.

(c) Recruitment Committee shall award the marks (out of 60 marks) only to the FIT candidates for their sports achievements & educational qualifications etc. Candidates declared 'NOT FIT' will not be assessed further by the Recruitment Committee.  
(d) Recruitment Committee is to add the marks given by the Trial Committee to the FIT candidates (i.e., out of 40 Marks), in order to make the final merit list (out of 100 Marks).

(e) **Distribution of Marks:** Maximum marks which can be awarded by the Trial Committee for performance during Trial and Recruitment Committee shall be as follows:-

- (i) For game skill, physical fitness & Coach's observations during Trials : 40 Marks
- (ii) For assessment of recognized Sports Achievements as per norms : 50 Marks
- (iii) Educational Qualification : 10 Marks

**Total : 100 Marks**

NOTE: The offer of appointment shall be given purely on the basis of merit. In case more than one sports person score the same marks, preference should be given to younger candidate to decide the merit.

8. All the candidates getting appointment through Sports Quota will undergo probation period of two years. If the performance of a person recruited on sports account is considered to be unsatisfactory, the probation period will be extended maximum up to two years and the person will have to improve his/her performance to get confirmed in appointment. Even after extended probation, if the performance is found unsatisfactory, then normal procedure will be followed for termination, before the completion of extended probation.

9. **Essential Certificates/Documents Required:** Copies of certificates of sports performance, educational qualification, date of birth, caste, etc. should be sent duly self-attested. There is no reservation for SC, ST and OBC being a sub-quota. However the candidates claiming to belong to SC/ST/OBC communities are required to submit self-attested photocopy of Caste Certificate issued by Competent Authority.

10. **HOW TO APPLY:** Candidates fulfilling the eligibility criteria should apply as per application format given at Annexure-A by the candidate in his/her own handwriting on a good quality A-4 size plain paper along with two recent (taken within last two months) passport size photographs duly self-attested without wearing any wig, cap or coloured glasses. The application should be duly filled and signed by the candidate in his/her own handwriting.

(a) Applications must be sent through ordinary post addressed to **Senior Personnel Officer (Recruitment), Northeast Frontier Railway/HQ, Maligaon, Guwahati - 781 011 (Assam)** OR dropped in the APPLICATION BOX in the Recruitment Section in the Office of Pr. Chief Personnel Officer, NF Railway/HQ, Maligaon, Guwahati (Assam) on or before **16.12.2019**. (For candidates residing in Andaman & Nicobar Islands, Jammu & Kashmir, Lahaul & Spiti Districts, Pangl Sub-Division in Chamba District of Himachal Pradesh, Lakshadweep and abroad, the last date is 26.12.2019 by post only). The envelope should be superscribed "RECRUITMENT AGAINST SPORTS QUOTA: EVENT - ..... & GP - ....." with the name of the event.

11. **FEES:** (i) For all candidates except those mentioned in sub-para (ii) below: **Rs. 500/- (Rupees Five Hundred) only with a provision for refunding Rs. 400/- to candidates actually appearing in the written examination/trial.** The IPO should be drawn in favour of PFA/NF Railway, and payable at Maligaon Post Office, Guwahati - 781011. Candidates must write their names & full address in the IPO.

(ii) For candidates belonging to SC/ST/Ex. Servicemen/Persons with Disabilities (PWDs), Women, Minorities and Economic Backward Classes: **Rs. 250/- (Rupees Two Hundred Fifty) only with a provision for refunding the same to those who actually appear in the trial.**

(iii) "Minority" means Muslims, Christians, Buddhists, Zoroastrians (Parsis) & Sikhs. **Economically backward classes** will mean those candidates whose family income is less than Rs. 50,000/- per annum. The following officials are authorized to issue income certificate for the purpose of identifying economically backward classes:

- District Magistrate or any other Revenue Officer up to the level of Tehsildar.
- Sitting MP of Lok Sabha for persons of their own constituency.
- BPL Card or any other certificate issued by Central Government under a recognized poverty alleviation programme or Izat MST issued by Railways.
- Union Minister may also recommend for any persons from anywhere in the country.
- Sitting MP of Rajya Sabha for persons of the District in which the MP normally resides.

The income certificate issued by the authorities mentioned in Para - 11(iii) above must be as per format given at Annexure-B enclosed herewith. This will have to be issued on the letterhead of the issuing authority.

(iv) A candidate applying for more than one event must submit separate applications with separate IPOs and complete documents for each event.

12. **Medical Examination:** The sports person (male/female) appointed, must fulfil the minimum medical norms for the post, for which he/she is being appointed.

13. **Important Instructions:**

- Spellings of name, father's name and other details in the application form must be as per the original certificates. If any discrepancy is found, the application can be rejected at any stage of the selection.
- Application which is not as per format (Annexure-A) will be rejected.
- Signatures of the candidates on all documents should be identical, either in English or Hindi, and must be in running hand writing and not in block/capital or disjointed letters. Any variation in the signatures or signature in different style or language at the time of Document Verification/Trial etc. may result in cancellation of candidature.
- If left thumb impression not affixed/blurred/smudged on the application form, the application will be rejected.
- The application will be rejected if the applicants are found over aged, under aged, date of birth unfilled or wrongly filled.
- IPO issued before the date of this Employment Notice will not be accepted and the application will be rejected.
- Candidates must write their name and address on the IPO and enclose it with the application form.
- IPO should be drawn in favour of PFA/MLG and payable at Maligaon Post Office only, otherwise application will be rejected. Cutting, erasing or overwriting on the IPO will summarily be rejected.
- Applications received with cash/cheque/Central Recruitment Stamp OR money order will not be accepted.
- Candidates of those candidates, who fail to appear for trials and other selection procedures on the date and venue fixed for the purpose, will be cancelled without further notice.
- Railway Administration reserves all rights for recruitment of sports persons at any time/position for which suitable outstanding sports persons are available.
- The application can be filled in either English or Hindi but item nos. 1, 2, 3, 4, 9, 10, 11 & 16 should be filled up in English only.
- Only self-attested copies may be sent with application form. Original Certificates should be produced only at the time of selection.
- Selected candidates will be liable to serve on any post/department anywhere in N.F. Railway subject to training courses, if any so prescribed.
- Selected candidates will be required to undergo medical examination as per the prescribed norms for different posts.
- Candidates already employed should submit their application through proper

channel or "No Objection Certificate" from the employer should be attached. Selected candidates will have to submit the Service Bond of five years at the time of appointment.

(xvii) The request for transfer of sports person recruited against Sports Quota to any other Railway/Division shall not be considered before completion of five years.

(xix) Verification of eligibility conditions with reference to original documents will be conducted only after the candidates are shortlisted for Document Verification/Trial. Railway Administration may reject the candidature of any applicant at any stage of recruitment process in case the candidate is found to be not fulfilling the requisite criteria and if appointed, such a candidate shall be terminated from service.

(xx) Candidate attempting to apply with minor changes of information and/or facts to submit multiple applications for the same post and discipline against this will be summarily rejected.

(xxi) The Offer of Appointment letter will be issued by the concerned authority where the candidate is posted subject to availability of vacancies and satisfying all eligibility criteria including Medical Fitness, antecedents and character.

(xxii) Selected male candidates who are finally appointed are liable for active service in Territorial Army.

(xxiii) Free Second Class Railway Pass admissible to SC/ST candidates when they are called for Document Verification/Trial (as applicable) as per the details of valid caste certificate furnished by them. At the time of obtaining reservation and travelling, the Reservation Clerk and/or Ticket Checking Staff will ask for the original SC/ST certificate for verification of genuineness of the candidate. Any attempt to misuse this travelling authority shall lead to rejection of candidature at any stage of the selection process including debarment for future examinations. Other than SC/ST candidates will have to make their own arrangements. No reimbursement of travel expenses will be made on any account. No TADA/Accommodation will be given for appearing in the selection procedure.

(xxiv) Candidate should be in readiness to appear for the Document Verification/Trial at short notice.

(xxv) The selection of the candidate by the Railway Administration does not confer any prescriptive right on the candidate for the post.

(xxvi) If there is any change in residential address, the candidate in his own interest should arrange with the Post Office concerned for redirection of the communication from old to new address.

(xxvii) N.F. Railway reserves the rights to conduct additional Trial at any stage. N.F. Railway also reserves the right to cancel part or whole of any recruitment process at any stage for any of the post notified in this Employment Notice.

(xxviii) In the event of any dispute about interpretation, the English version will be treated as final.

(xxix) In the event of any is-statement/discrepancy in the particulars/incomplete or invalid application or candidates has suppressed any relevant information or the candidates otherwise do not satisfy the eligibility criteria for the post being detected at any stage, his/her application/candidature will be cancelled or services will be terminated without any notice.

(xxx) For any legal dispute the jurisdiction will be of Central Administrative Tribunal/Guwahati.

14. **Miscellaneous:**

(i) Railway Administration reserves rights to rectify any inadvertent error or omission at any stage of recruitment/appointment and an erroneously appointed candidate shall be liable to be terminated from Railway Service. N.F. Railway will not be responsible for any inadvertent error.

(ii) The decision of the Railway Administration in all matters relating to eligibility, acceptance or rejection of applications etc. will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection.

15. **Conveyancing:** Conveyancing in any form, misbehaviour or misconduct will lead to summary rejection and cancellation of candidature and no correspondence will be entertained in this matter.
